This Memorandum of Understanding (MoU) is made on this day 01.09.2025

BETWEEN

Srikrishna College, Bagula, Nadia is an Undergraduate Institute affiliated under the University of Kalyani, West Bengal. It was established in 1952 primarily as a Commerce college and later spread its wings with Arts and Science divisions as well. Srikrishna College, hereinafter referred to as "SKC" has been accredited by NAAC (UGC) with Grade "B+" in the Third Cycle. Located almost 100 kms away from the heart of the capital city of Kolkata, SKC, stands committed to spread education and an all-round holistic development primarily to the rural and semi-urban students of Bagula and its adjoining areas with its eleven departments in Humanities, six departments in Science and the department of Commerce.

AND

Birangana Sati Sadhani Rajyik Vishwavidyalaya has been established by the Government of Assam under the Birangana Sati Sadhani Rajyik Vishwavidyalaya Act 2020. The university has been allotted land in Rangajan under Morongi Revenue Circle of Golaghat District. Presently, the office of the Vice Chancellor is run from Golaghat Engineering College premises. The mission and vision of the university are to develop global citizens through a holistic learning process, and endeavouring to turn it into a hub of multidisciplinary research and academic excellence for all its stakeholders.

(SKC and BSSRV hereinafter referred to singularly as "the Party" and collectively as "the Parties")

WHEREAS

- A. The Parties are desirous of entering into this MoU to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties upon the terms as contained herein.

SKC AND BSSRV HAVE REACHED AN UNDERSTANDING AS FOLLOWS:

1. OBJECTIVE

The Parties, subject to the terms of this MoU and the laws, rules, regulations, and national policies from time to time in force in each party's country, will endeavour to strengthen, promote, and develop cooperation between the Parties on the basis of equality and mutual benefit.

2. AREAS OF CO-OPERATION

2.1 Each Party will, subject to the laws, rules, regulations, and national policies from time to time in force, governing the subject matter, endeavour to take the necessary steps to encourage and promote co-operation in the following areas:

- a) Placement of Students
- b) Statistical Analysis of data
- c) Online Enrichment Program/Conferences
- d) Exchange of faculty;
- e) Jointly organize international conferences; and
- f) Any other areas of co-operation to be mutually agreed upon by the Parties from time to time.

3. FINANCIAL ARRANGEMENTS

3.1 This MoU will not give rise to any financial obligation by one Party to the other.

3.2 Each party will bear its own cost and expenses in the implementation of this MoU.

4. CONFIDENTIALITY

4.1 Each Party shall undertake to observe the secrecy of confidential information received from or supplied to the other Parties during the period of implementation of this MoU or other agreements made pursuant to this MoU.


4.2 All Parties agree that the provisions of this Clause shall continue to be binding between the Parties notwithstanding the termination of this MoU.

5. INTELLECTUAL PROPERTY RIGHTS

5.1 The intellectual property rights shall be enforced in conformity with the respective national laws, rules, and regulations of the Parties and with other international agreements signed by both Parties.

5.2 The use of the name, logo and/or official emblem of any of the Parties on any publication, document and/or paper is prohibited without the prior written approval of either Party.

6. EFFECT OF MoU

This MoU serves only as a record of the Parties' intentions and does not constitute, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

7. NO AGENCY

Nothing contained herein shall be construed to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either Party as the agent of the other.

8. ENTRY INTO EFFECT AND DURATION

8.1 This MoU will come into effect on the date of signing and will remain in effect for a period of **Five (5)** years.

8.2 This MoU may be extended for a further period as may be agreed in writing by the Parties.

9. SETTLEMENT OF DISPUTES

Any difference or disputes between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall be settled amicably through mutual consultation and/or negotiations between the Parties without reference to any third party or international tribunal.

10. COMPETENT AUTHORITIES

The authorities responsible for the fulfillment of this MoU are the –Principal of SKC and the Vice Chancellor of BSSRV.

The foregoing record represents the understandings reached between SKC and BSSRV upon the matters referred to therein.
